It is very important that we are part of the process as livelihoods will be affected due to decision making. We feel, as a group, that 'business as usual' shall prevail and we do not want to be impacted by special permits (parks), additional quotas, closed areas, wildlife regulation changes, etc.

In my experience, in the past, in other jurisdictions, it has been evident how these rulings can snowball into a difficult management situation. As the process continues, I have seen industry and political decisions disrupt the original intention of making areas such as the Peel, a well managed special place with wildlife and habitat as its priority. Also, a critical point, is the financial longevity of this project so the plan does not dissolve because of lack of funding in the future.

The Outfitting industry must be kept at the forefront and grandfathering of our traditional infrastructure untouched. The above Outfitters have all spoken with their Biologists and I am sure you will find some of their wildlife information helpful.

I will look forward to working with you towards a Watershed that will benefit and remain pristine from good decision making for many years to come.
