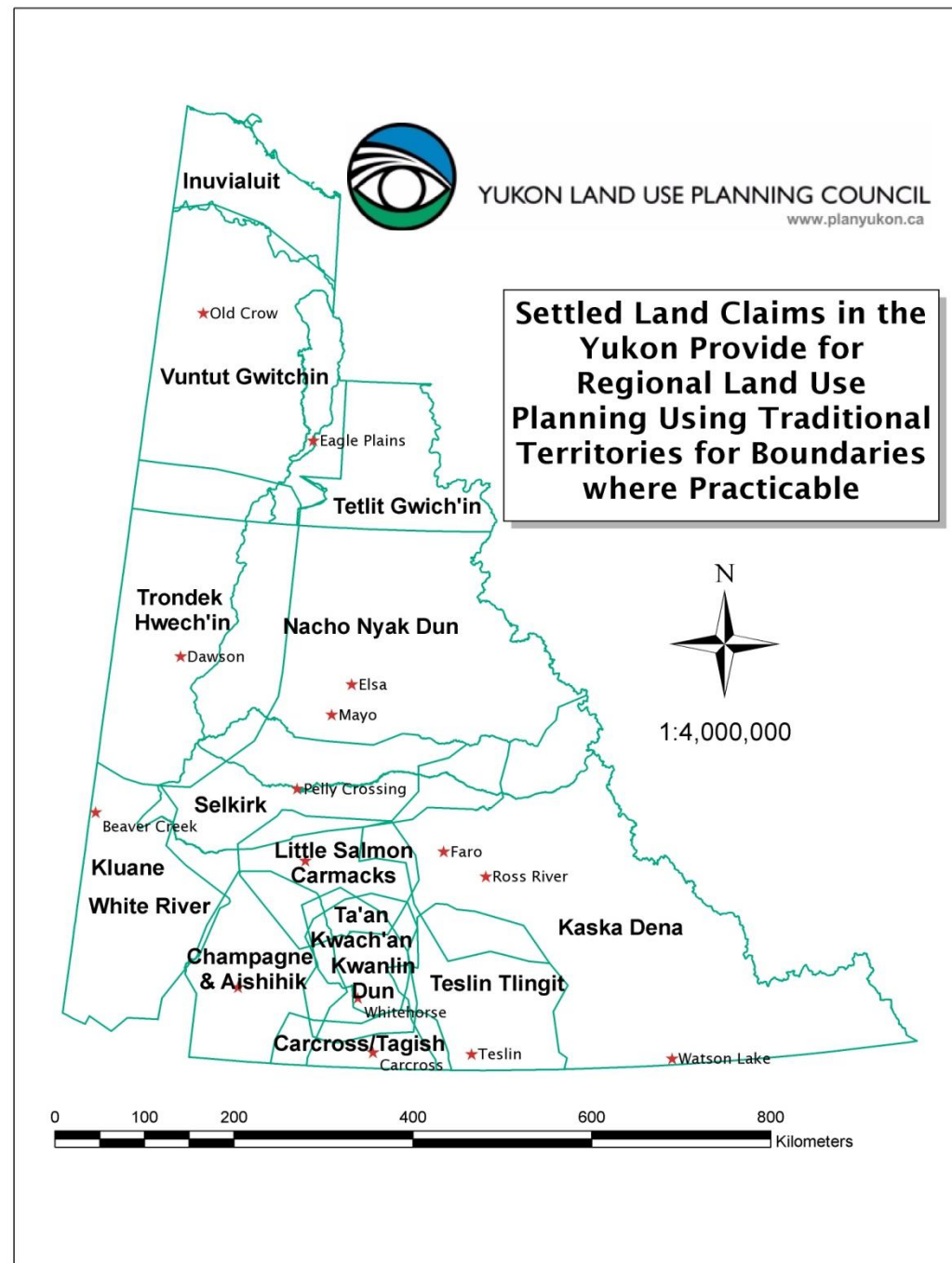

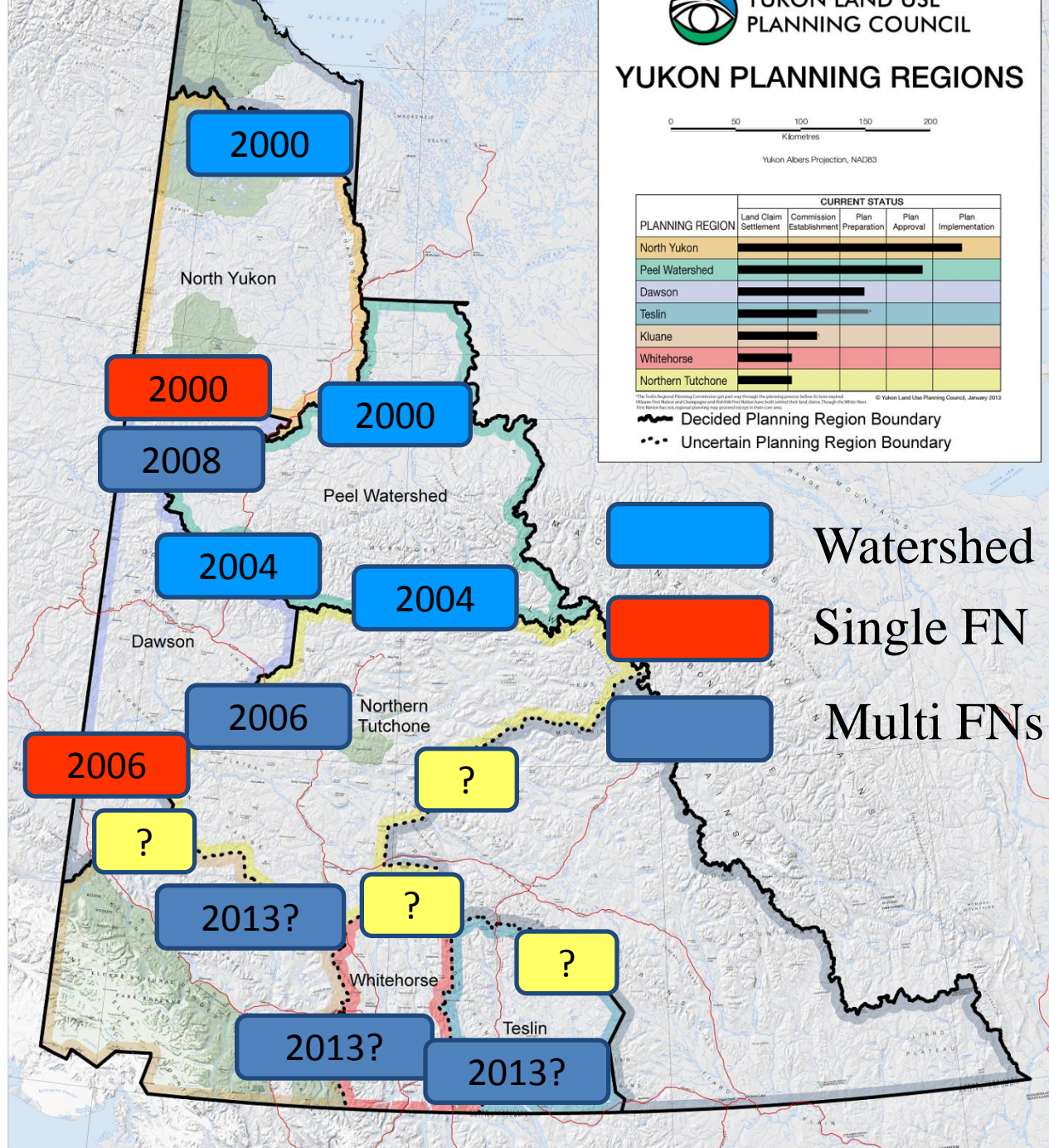

Though the Whitehorse First Nations has not regional planning has proceeded based on their own area.

- DRPC was developing a plan (draft plan stage)
- Reviewing Our Planning Process (CLUPP Review)
- Developing Southern Yukon Regional Planning Terms of References (primarily Kluane and Teslin)
- Implementing North Yukon Plan
- Funding Left from \$7.3 million: \$4.1 million

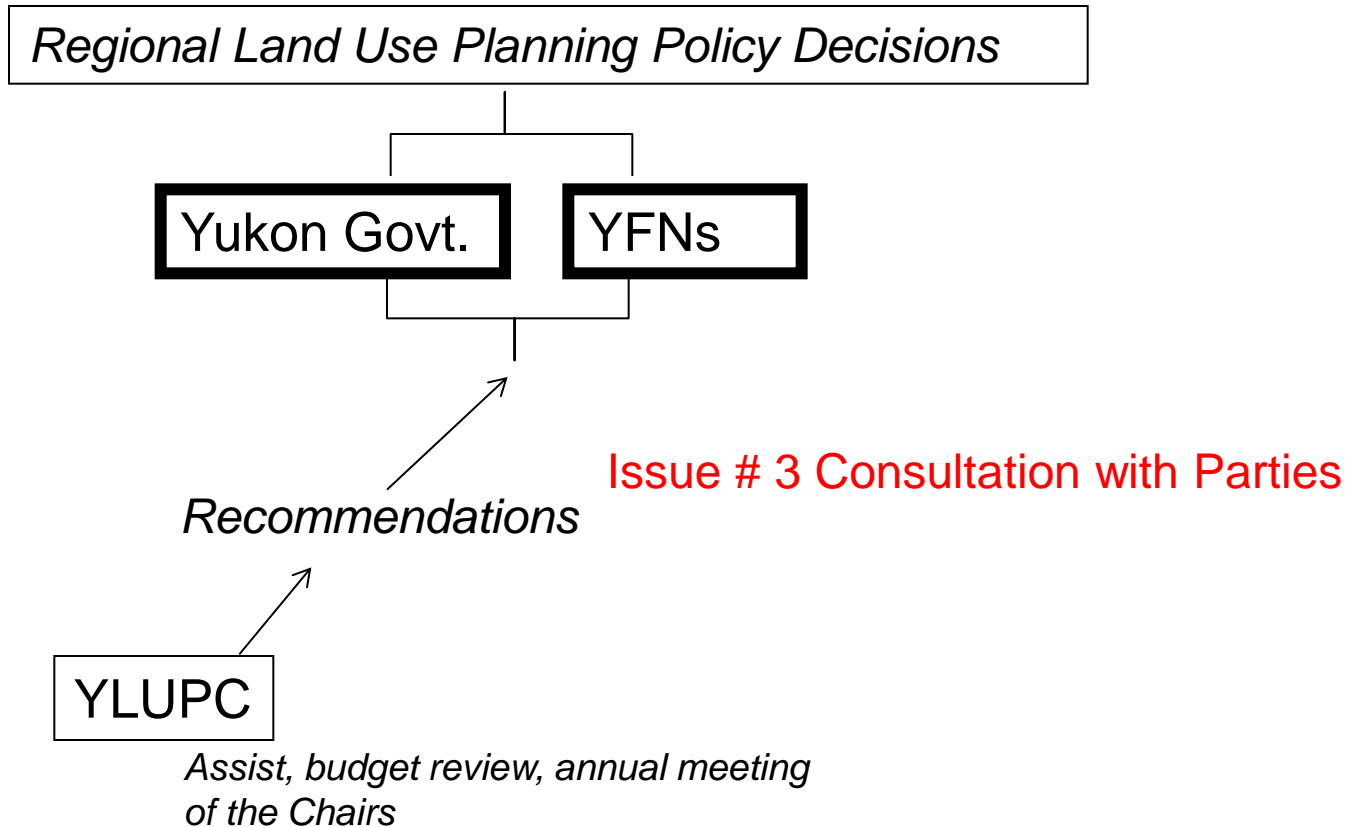


Figure 2: Chapter 11 Roles and Responsibilities

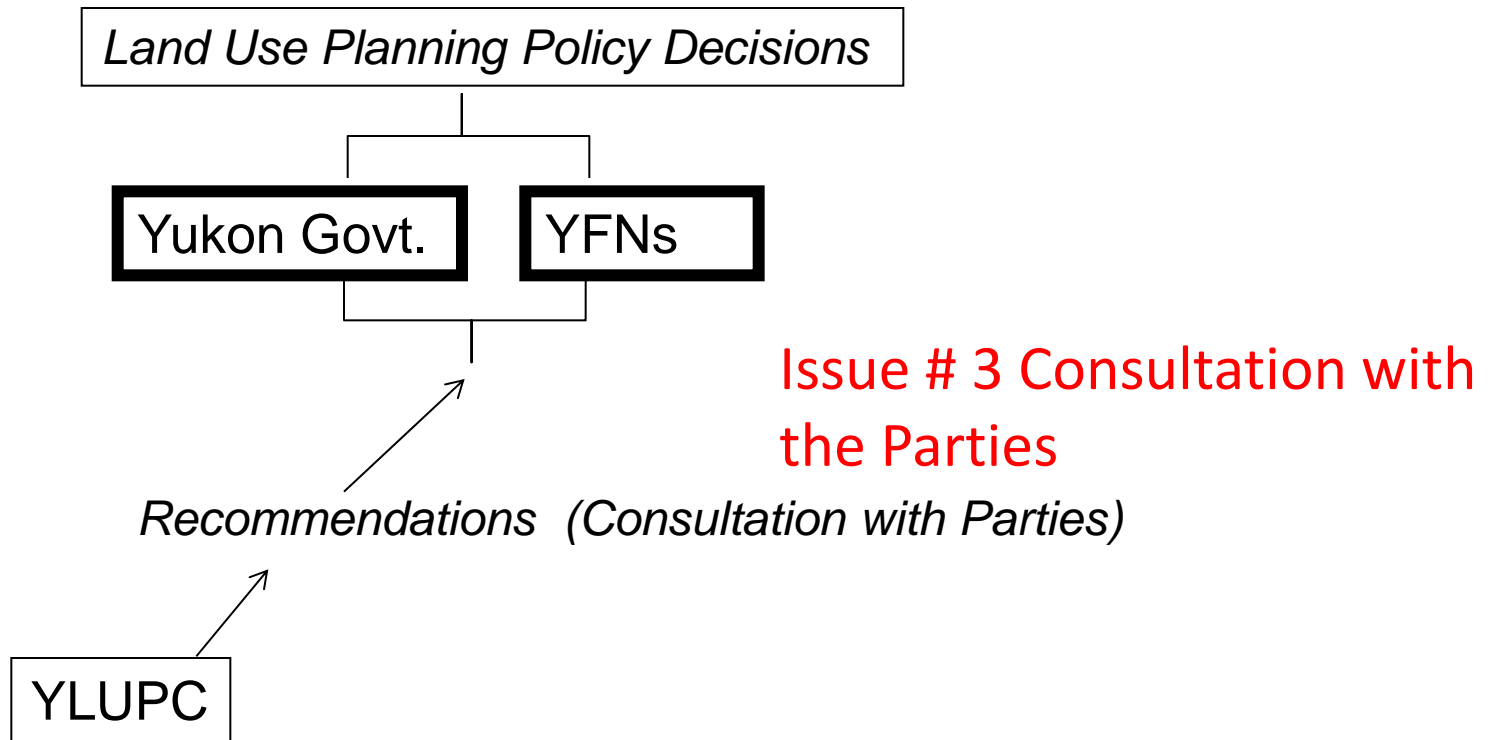
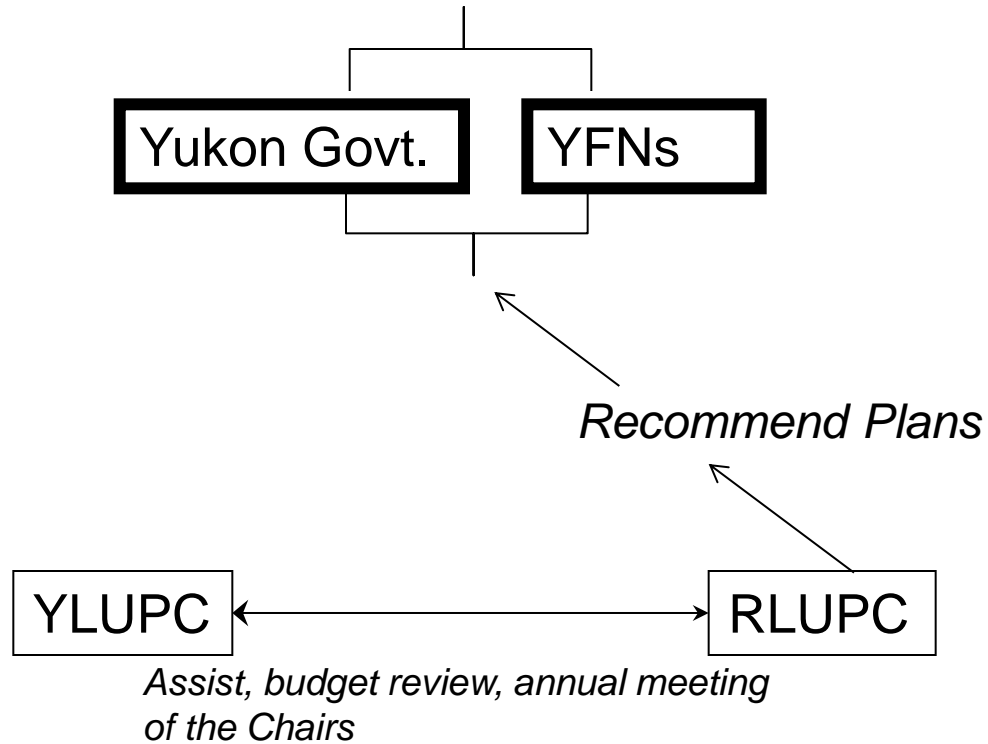


Figure 2: Chapter 11 Roles

Regional Land Use Planning Policy Decisions



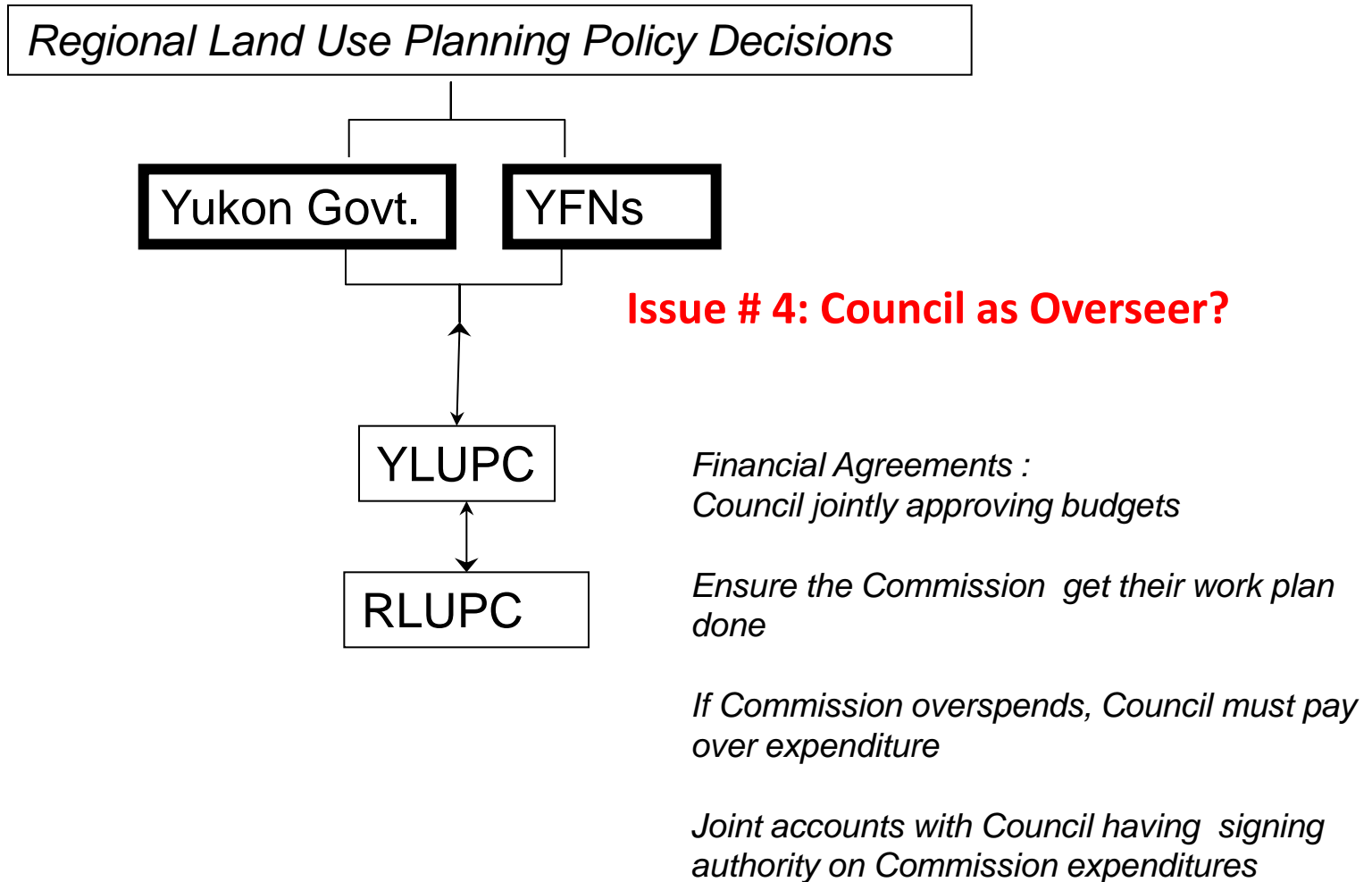
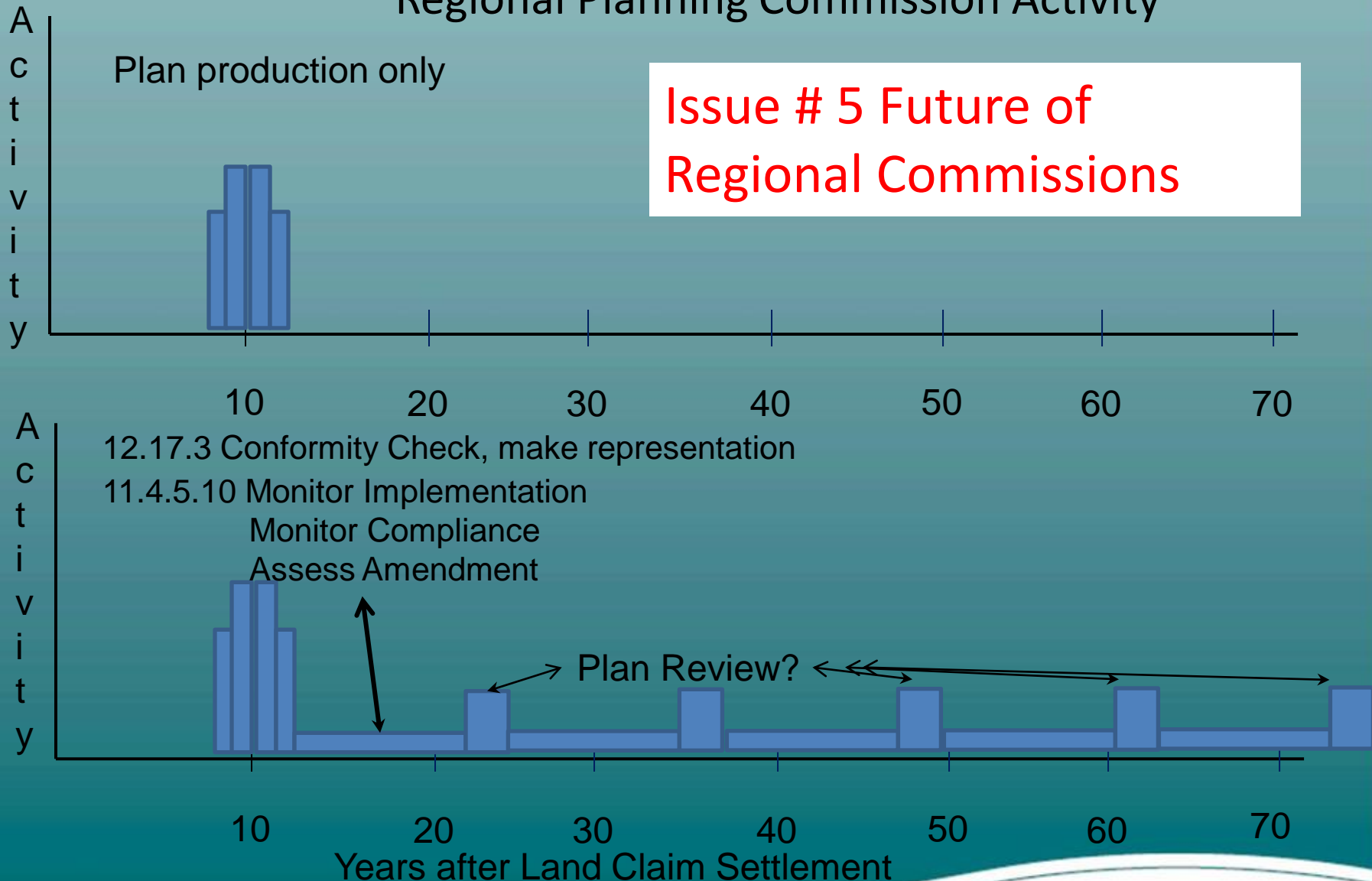


Figure 3: Council as Overseer?

Issue # 5 Future of Regional Commissions



CLUPP Improvement

- Organizational structure and process that would take the “weight of the world” off the Regional Commissions: more responsibilities to the Council, the Parties and other UFA Boards.
- Planning process changes that better define the perimeters of the work of the Commission before they begin: More upfront agreement between approval Parties

CLUPP Improvement

Yukon Land Use Strategy and/or Regional Land Use Strategy,
Terms of Reference - Precise Terms of Reference → Work Plan
and Budget.

Plan Development without Plan Alternatives and/or Draft Plan

Information Collection and Resource Assessment: Reduce
Increase focus on Regional Scale Impact Assessment
