

Post-land claim documents: Potential Roles the Council

1. The Land Claim Agreement Implementation Plans (UFA IP, 1995)

- Assisting Commission;
- Review of Commissions Budgets;
- Propose budget to Minister for its own (YLUPC) and Commissions budget. Funding for the Commissions flow through the Council by multi-year contribution agreement
- Organize Annual Meeting of the Chairs

Yukon First Nation Final and Self-Government Agreement Implementation Reviews (October 3, 2007)

- Provide support for Commissions work, particularly administrative
- Facilitate communication among Parties, Commissions
- Develop and promote CLUPP
- Draft a land designation system
- Develop Policy and procedure for Commissions
- Council assist but not to “take over” regional planning function of commissions
- Identify table of content of a regional land use plan, production schedule
- Provide training and orientation and “starter kit” material
- Council monitor the progress of Commission, with the Parties
- Council assess the planning experience on a ongoing basis (e.g. CLUPP review)
- Council do less advocacy work
- Council develop long term planning priorities and scheduling criteria
- Council to participate informally and collaboratively in the development of the annual budgets
- Council provide centralized data storage, records maintenance for use when plan is updated, record of relevant decision

3. The Terms of References for Regional Planning Commissions (DRPC TOR, 2012)

- Provide all staff support for the Commission until it has its own staff
- Council secure funds for Commission for start-up period
- provide Policy and Procedures handbook to commission, commission to consult Council before changes to policy
- Involved at key stages of the planning process: periodic opportunities for consultation on issues, process and draft products;
- Monitor compliance with funding agreement: receive agendas, minutes, progress reports
- Develop MOU with Commission
- Monitor compliance with the work plan
- Provide any existing information to Commission
- Budget/work plan review
- Attend Senior Liason Committee meetings, when asked
- Technical Working Group membership
- Training and Orientation responsibility of appt. Minister (Annex B, Part 2) (not Council)
- Recommend changes to ToR before Parties make them

4. The Financial Agreements with Yukon Government regarding Commission Funding

- Council provide financial and administrative review of the Annual Work plan and Budget
- Consider changes to the work plan/budget over the fiscal year (anything over 5% in budget)
- Monitor budget and work plan compliance, budget variance
- Ensure that the Commission meets its requirements in accordance with this Agreement
- Provide funding to cover a Commission over-expenditure or non- appropriate expenditure
- Remedial action planning in the event the commission is in default (with Yukon);
- Retain copies of the Commission's financials for 7 years (send their records to us each year?)
Council not identified to be involved in Plan Review, conducting conformity checks or monitoring land use plan implementation, nor "Oversee" the planning program.
